Network Branding

Since the last newsletter PELiCaN has agreed on a network brand image. Initially the brief was suggested to include; caring hands, family, umbrella, pelicans and circles. Keeping in mind that the network's stakeholders are families who are experiencing the end of their child's life (0-25yrs) or professionals who are working with these families, any designs would need to be mindful of that. Two final options were taken to the West PELiCaN roadshow and delegates had the opportunity to feedback on these designs. From feedback an amended design in terms of colours of the image was taken to the first network steering group members fed back that they would like to incorporate rainbow colours to reflect rainbow rooms and the spiritual warmth of a soul having passed 'over the rainbow . Final changes were made and the final design was circulated to the group, and a great deal of positive feedback was received.
