## **Terms of Reference**

## 1. Purpose of End of Life Care Group

To work in partnership, with all who are involved with caring for those who are living with advanced illness, those who are moving in to the last weeks and days of life and those who are dying so that they have the care they need, when and where they need it. This includes care delivered in all settings and the support of families and carers.

## 2. Aim

The aim of this group will be to support improvements in people's experience of their or their loved ones last hours, days or weeks of life.

## 3. Objectives

The End of Life Care Group will be responsible for:

- Identifying and supporting selected projects brought to the group
- Ensuring close integration of work with colleagues in health, social care, the independent and voluntary sector
- Facilitate the sharing of learning from projects with colleagues in Tayside and more widely as appropriate

## 4. Chair Person

This group is co-chaired by Dr Shawkat Hasan, GP Partner/ Clinical Lead OOH, NHS Tayside and Gill Tomison, Palliative Advanced Nurse Practitioner, Cornhill Macmillan Centre, PRI. This group will benefit from the additional leadership of a Nurse Consultant for Palliative and End of life Care for NHS Tayside (to be appointed).
